The following specific statements, actions, or facts give rise to a reasonable fear of significant dangerous acts by the respondent:

On April 26, 2026, Deputies responded to \_\_\_\_\_ in Ormond Beach in reference to a suicidal female. Volusia Sheriff's Office Dispatch advised a female who was on scene stated the female of interest was making suicidal statements and locked herself in a room. Volusia Sheriff's Office Dispatch also was advised the female has two guns in her possession and did say she would shoot herself.

Upon arrival Deputy Griswold contacted \_\_\_\_\_ (R1) who advised the following:

\_\_\_\_\_ advised her lifelong friend \_\_\_\_\_ (VI) is recently divorced from her husband of 26 years due to him leaving her for another woman. \_\_\_\_\_ explained that her recent divorce and her mother's declining health have caused \_\_\_\_\_ to become upset. \_\_\_\_\_ stated today, \_\_\_\_\_ began to have a break down where she began throwing things inside of the home and told \_\_\_\_\_ that she was "going to shoot herself." \_\_\_\_\_ questioned \_\_\_\_\_ if she had any firearms inside the home and \_\_\_\_\_ stated, "Yes two" and pointed to a bedroom inside of the home. \_\_\_\_\_ then went inside of bedroom where the firearms were and locked the door. \_\_\_\_\_ tried talking to \_\_\_\_\_ from the outside of the door but did not received a response. \_\_\_\_\_ stated she was calling law enforcement and \_\_\_\_\_ then exited the room and sat on the couch in the living room. \_\_\_\_\_ told Deputy Griswold she did not witness \_\_\_\_\_ in possession of firearms at any time.

Deputies contacted \_\_\_\_\_ inside of her residence where she confirmed she was feeling suicidal but was not going to shoot herself.

Due the results of the investigation, Deputy Griswold determined \_\_\_\_\_ posed a risk to herself if Deputy Griswold did not intervene; therefore, \_\_\_\_\_ was placed into protective custody under a Baker Act and transported to Halifax Hospital.

\_\_\_\_\_ willingly turned over her firearms which were two handguns.


