On 03/01/2026 at 0008 hours, Deputy Schramm was dispatched to [REDACTED] in reference to a suicidal person.

According to dispatch notes, a concerned party from Canada was calling about [REDACTED]. The reporting party, [REDACTED] advised that [REDACTED] had messaged her on Discord saying that he had shot himself and that he was going to shoot himself in the head if she didn't answer the phone. [REDACTED] was concerned and contacted Law Enforcement. [REDACTED] also provided screenshots of the conversation, which were uploaded to evidence.com.

Deputy Schramm responded to the area and attempted to locate [REDACTED] on the property. Deputy Schramm made contact with [REDACTED], who is [REDACTED] Grandfather. [REDACTED] advised that [REDACTED] usually stays in a separate trailer on the property, has no access to firearms, and does not currently own any firearms.

Deputies continued to check the area until [REDACTED] was located walking westbound on [REDACTED]. [REDACTED] attempted to run from Deputy D. Dahlen but was stopped, placed in handcuffs, checked for tightness, and escorted to Deputy Schramm's marked patrol vehicle. While Deputy Schramm was escorting [REDACTED] stated, "I said I wanted to shoot myself for attention, okay?! That bitch is ruining my life." Deputy Schramm placed [REDACTED] into protective Custody under the Baker Act and was transported to Stewart Marchman for further mental health evaluation.

The screenshots of the messages were uploaded to evidence.com. No firearms or ammunition were located.

It should be noted that [REDACTED] username on Discord is "Fuxk.it." and "GENUINELY FUCK EVERYTHING"
